 - b. Discuss, consider and take appropriate action if necessary on the proposed combination drilling and operating permit, for Linda and Mike Fletcher, authorizing drilling and withdrawal from a proposed well in the Middle Trinity (Hensell) aquifer with a 1 1/4 inch column pipe on a .5 acre tract located on (Prop ID 399907) Spruce Dr. in Morgan's Point, TX, Latitude 31.15305°, Longitude -97.48941666°, to produce water for domestic use in a proposed annual quantity of 316,860 gallons per year or 0.97 acre-feet per year.
 - c. Discuss, consider and take appropriate action if necessary on the proposed drilling permit to authorize drilling of a new well by Jack Hillard Dozer & Materials in the Lower Trinity (Hosston) aquifer with a 6 inch column pipe on a 120 acre tract located at 12495 Reed's Lake Loop, Temple, Texas, Latitude 30.3961194444°, Longitude -97.30894444 to produce water for industrial use, with a proposed annual withdraw is 23,852,293 gallons or 73.2 acre-feet.
