Board meeting opened with President, Leland Gersbach at 1:30 p.m.

1. Invocation and Pledge of Allegiance:

Vice President, Wallace Biskup, gave the invocation. Director, Bill Bartlett, lead the Pledge of Allegiance.

3. Approve minutes of the August 12, 2014 Board Meeting and Workshop.

Vice President, Wallace Biskup, moved to approve the Minutes of the August 12, 2014 meeting. Secretary, Judy Parker, seconded the motion. **Motion carried 5-0.**

4. Hold Public Hearing on the proposed tax rate for tax year 2014.

President, Leland Gersbach, opened the public hearing. Dirk Aaron recommended the Board set the tax rate at \$0.0040/\$100 valuation for tax year 2014. Dirk explained that with certified values of \$15,586407,689.00 the rate of \$0.0040/\$100 would generate \$623,456.000.00 in revenue for the District.

Public Hearing opened with President, Leland Gersbach, at 1:35 p.m.

Leland Gersbach opened the hearing for public comment. No comments made.

Public Hearing closed and Board meeting reconvened with President, Leland Gersbach at 1:37 p.m.

5. Discuss, consider and take appropriate action if necessary to adopt the District Budget for FY2015.

General Manager, Dirk Aaron gave a brief synopsis of the proposed budget for FY15. He commented that it was the same as discussed and recommended in workshop. The proposed budget includes anticipated tax revenue of \$623,456.00 plus a\$26,500.00 in anticipated revenue from delinquent taxes from previous years, application fees, transport fees, and interest, for a total of \$649,956.00.

Dirk pointed out items of interest and discussion points in the proposed budget. These items were discussed in workshop.

Staff recommended that the Board review proposed budget, make final changes and adopt District Budget of \$649.956.00 for FY15.

Director, Bill Bartlett, moved to accept the proposed budget as stated. Vice President, Wallace Biskup, seconded the motion. **Motion carried 5-0.**

6. Discuss, consider and take appropriate action if necessary to adopt the District Tax Rate for tax year 2014.

Based on information and discussion in the Public Hearing, Leland Gersbach asked for a motion to approve the District Tax rate.

Vice President, Wallace Biskup, moved to approve the District Tax Rate of \$0.0040/\$100. Secretary, Judy Parker, seconded the motion. **Motion carried 5-0.**

7. Discuss, consider and take appropriate action if necessary to amend the FY14 Budget as presented.

Dirk Aaron informed the Board that the FY14 Budget amendments will be presented at the Sept. 9th meeting. Some invoices were coded to the wrong line item and needed to be corrected. The dollar amounts aren't affected, just account codes. Our QuickBooks consultant has assisted Shelly with the corrections.

8. Discuss, consider and take appropriate action if necessary to amend the previous call for the November 4th General Election of Directors.

Dirk informed the Board that the Call for Election stands as originally stated. No changes necessary.
